

**NOTES FOR APPLICANTS APPLYING FOR RESERVED SEATS IN
MEDICAL/DENTAL COLLEGES FOR SONS, DAUGHTERS AND WIDOWS OF
DISABLED PERSONNEL, GALLANTRY AWARD WINNERS, ESM AND SERVING
PERSONNEL OF THE ARMED FORCES**

1. Eligibility Criteria's:-

(a) Selection of candidates for Central seats reserved for Nominee of Govt of India. The selection will be made on the basis of marks obtained by the students in National Eligibility cum Entrance Test (NEET) conducted by CBSE.

Candidates who do not qualify the NEET should not apply.

(b) Only wards of Defence Personnel from Army, Air Force & Navy from P-I to P-VII are eligible for the scheme.

(c) All cases of disability in r/o of defence personnel (P-III & P-IV), which are due to reasons Aggravated by military service (Not Attributable) are not eligible.

(d) Wards of civilians/civilians working in AFHQ/MoD, DRDO wards of personnel from para military/CAPF are not eligible.

(e) Scheme is open to Indian nationals only.

(f) This facility is admissible for only one member of the family.

(g) Candidates should have attained the age of 17 years on 31 December of the academic session in which the admission is sought for.

2. Instructions:-

The following instructions are given for information and guidance of the eligible applicants:-

(a) Applications by eligible candidate will be submitted online along with supporting documents as given in para 4 below. Serving Personnel will submit application online along with scanned copies of documents duly authenticated by CO/OC Unit as per para 4 **within 21 days of declaration of NEET results.**

(b) Incomplete application forms and applications received after the specified date will NOT be considered. A wrong or misleading entry will lead to rejection of the application.

(c) Selected candidates will be informed directly by the Kendriya Sainik Board, Ministry of Defence, West Block-IV, Wing No. 7, RK Puram, New Delhi-110066. The Toll Free Tele No. is 1800115250 and E-mail ID- jdadmcoordksb-mod.gov.in

(d) Nomination made will be subject to the candidate fulfilling the admission requirement of the Institution/University concerned.

(e) If an applicant, admitted on the basis of the information furnished by him/her and subsequently found to have made false statement in any respect, he/she will be removed from the college, Fees and other dues paid by the candidate shall NOT be refunded.

(f) Candidate admitted against the reserved seats will have to execute a Bond with the Government of India, Ministry of Health or the State Government or the Administration of Union territory as the case may be to serve the Government concerned for the specified period after qualifying for registration as a Medical/Dental Graduate.

(g) If selected candidate is refused admission by the Medical/Dental College concerned due to non-fulfillment of admission requirements he/she will not have any claim for his/her transfer or admission to some other Medical/Dental college.

(h) The seat offered will be final and no request for change will be entertained. Candidates who fail to send their acceptance by the prescribed date will forfeit their nomination.

(i) Once a candidate has been informed about his/her selection by the Kendriya Sainik Board, he/she should send his/her confirmation of acceptance telephonically as well as by fax on No. 011-26192362, e-mail (jdadmcoordksb-mod@gov.in) within specified date.

(j) Separate applications are to be submitted for MBBS and BDS courses.

(k) The attested photocopies of the supporting documents both by Director, Rajya/Zila Sainik Board and OIC Records, in case of actual and legitimate children (including validly adopted sons/daughters prior to the death of the deceased), are to be uploaded with application form.

(l) The selection within Priority-V will be strictly in the order of Gallantry awards.

(m) The Candidates must clearly mention the Priority in his/her application as listed below:-

Priority-I :Widows/Wards of Defence personnel killed in action

Priority-II :Wards of disabled in action and **boarded out** from service

Priority-III :Widows/Wards of Defence personnel who died while in service with death attributable to military service.

Priority-IV :Wards of disabled in service and **boarded out** with disability attributable to military service

Priority-V : Wards of Ex-Servicemen and serving personnel who are in receipt of Gallantry Awards:-

- (i) Param Vir Chakra
- (ii) Ashok Chakra
- (iii) Sarvottam Yudh Seva Medal
- (iv) Maha Vir Chakra
- (v) Kirti Chakra
- (vi) Uttam Yudh Seva Medal
- (vii) Vir Chakra
- (viii) Shaurya Chakra
- (ix) Yudh Seva Medal
- (x) Sena, Nau Sena, Vayu Sena Medal
- (xi) Mention-in-Despatches

Priority-VI : Wards of Ex-Servicemen

Priority-VII : Wards of Serving Personnel

(n) All Eligibility Certificate will be recommended by the ZSWOs/RSBs of the individual soldier/airmen/sailor/JCOs/Officers. Under Priority-V & VII **in case of Serving personnel only** the eligibility certificate can be signed by only CO/OC Unit. Attested copy of Gazette notification/Part II order also to be uploaded.

(o) Litigation if any, are restricted to jurisdiction of Delhi Courts only.

(p) Instructions given above are to be used as guidelines only, these are subject to change without notice as per MCI/Ministry of Health rulings issued from time to time.

3. **Criteria for Drawing Merit List/Selection**

Merit list will be prepared priority wise and within each priority as per the NEET score. The merit list will be displayed on the website on finalization.

4. **CHECK LIST FOR DOCUMENTS TO BE UPLOADED WITH THE APPLICATION FORM**

The following documents are to be uploaded with the application form:-

- (a) Self attested photocopy of the marks-sheet of Matriculation examination.
- (b) Self attested photocopy of the marks-sheet of 10+2 or equivalent examination.

(c) Self attested copy of Result/Merit of National Eligibility cum Entrance Test (NEET).

(d) Eligibility certificate will be duly signed by ZSB/RSB and countersigned by OIC Records. For serving personnel in priority V and VII, eligibility certificated can also be signed by CO/OC Unit.

(e) Self attested photocopies of Education Entitlement Card, latest Pension Payment Order, Special/Liberalized family pension, Casualty Indicating Disability, or documentary proof of Gallantry Award, as applicable.

(f) Passport size photograph.
